

- iii. An Affidavit on Rs. 100/- Non-Judicial stamp paper by the Applicant is required to be submitted alongwith individual affidavits on Rs.10/- Non-Judicial stamp paper as per the prescribed format to be submitted by the academic staff duly selected and appointed.
 - iv. The institution shall launch its website covering, *inter alia*, the details of the institution, its location, name of the course applied for with intake, availability of physical infrastructure (land, building, office, classrooms, and other facilities/amenities), instructional facilities (laboratory, library etc.) and the particulars of their proposed teaching and non-teaching staff etc. with photographs. **The downloaded copies of the website is to be submitted**
4. Admission should not be made until formal permission order under Para 7(11) of the NCTE (Recognition Norms & Procedure) Regulations, 2007 is issued by the Eastern Regional Committee, NCTE and affiliation is obtained from the University/ examining body concerned.
5. You are advised to comply the above requirement before formal permission is considered under Regulation 7(11). The reply along with supporting relevant documents may be sent to ERC, NCTE, within **20 days** of the issue of this letter.
